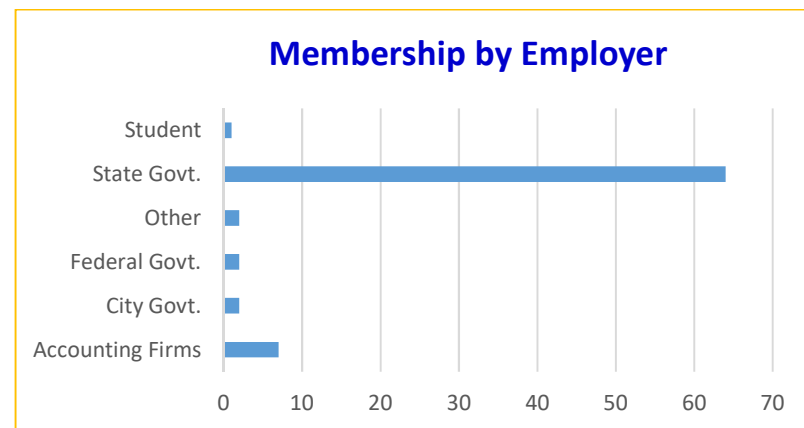
A 2023 Report to Our Membership

We did increase membership by 3 members. We were able to recruit 13 new members to offset the 10 we lost to job changes and retirements. We will continue to spread the word about the benefits of an AGA membership.

By continuing our CGFM study groups we increased the number of CGFMs by 47%. The reimbursement program is working well. Though the CGFM reimbursement program is one of our largest expenses, we believe that it is one of our most important. Our chapter has great teachers, who lead interesting study groups and help our members meet their goal of becoming CGFMs.
#3 Promote AGA and CGFM to students <ul style="list-style-type: none">✓ Outreach to high schools, colleges, and universities✓ More information on our website✓ Provide more opportunities for students to get involved	We were partially successful with this goal. Our Chapter attended a Careers In Government event at a local university. We were able to tell students about the benefits of AGA. The Chapter hosts a Spring and Fall Education Conference and students from local colleges and universities are invited to attend free of charge.

We continue to work to make our Chapter better for our membership and provide them the benefits they need. Though we did not meet all of our goals last year, we were able to partially meet them all.

Community Service

We held a food drive for Manna Meal. Manna Meal is a soup kitchen and food pantry that serves free breakfast and lunch daily – 365 days a year. They are located inside St. John's Episcopal Church in downtown Charleston.



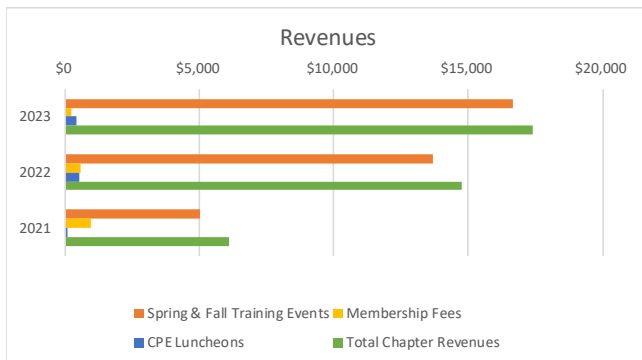
Our Finances

What were the costs for servicing the membership and how were those costs paid?

The Charleston Chapter is a non-profit organization operating solely on funds raised or donated through various functions. For fiscal year 2024, the Charleston Chapter plans to continue funding its activities through fees for educational programs and working to obtain sponsors for various events throughout the year.

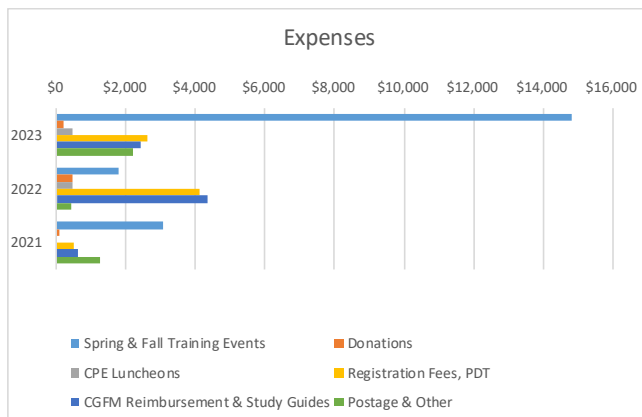
Revenues continued to increase in 2023, as more people were able to attend our in-person spring and fall training events. The 2021 revenues reflect two virtual events. The cost of the training events increased in 2023, due to both spring and fall being held in person. In 2022, the costs were lower as one event was held in-person and the venue had been paid in 2020 prior to the pandemic. The reservation was held by the venue until we were able to hold in-person events. The costs associated with the spring and fall training events declined in 2021 as both events went virtual in response to the pandemic. We were able to hold two in-person CPE luncheons in 2023 and 2022 increasing revenues and expenses. Due to the pandemic CPE luncheons also were held virtually in 2021 at no cost. CGFM expense increased in 2023 as more people from the study group passed parts of the exam and additional study materials were needed for larger study group classes.
