### 2011-2012 Accomplishments

- Provided a total of 9 hours of continuing professional education (CPE) hours at monthly luncheons.
- Offered 14 hours of CPE at annual regional PDC.
- Collected over \$1,000 for community service events.



### **Quality Education**

The Dallas Chapter received positive feedback for the quality of the educational opportunities provided during 2011-2012. The Dallas Chapter conducts monthly luncheons at the City Club in Dallas every third Thursday of the month. One meeting was a joint meeting with the Institute of Internal Auditors. Additionally the Dallas Chapter held a two day annual regional PDC in April 2012. It was a milestone of the Dallas Chapter as more than 78 attendees from the federal, state, local, nonprofit, and private sector attended the PDC during a time of budget constraints.

# **Community Services**

The Dallas Chapter continues to actively participate in many community service events and collects contributions and raffles for various causes. In 2011-2012, the Dallas Chapter donated baby food and diapers to North Dallas Food Bank, toys to Toys for Tots and gift bags to Open Arms Program which is a non-profit organization protecting women of domestic violence. Additionally, the Dallas Chapter collected contributions for the following community service events.

# Finances Revenue and Expenses


The Dallas Chapter had a net profit of \$3,457 in 2011-2012. The main sources of revenue were the annual regional PDC registration fees and sponsor contributions. Of the \$18,890 in expenses, over 90 percent is made up of PDC and monthly meeting expenses.

Although revenue from the regional PDC was lower than last year, the expenses were substantially lower allowing us to make a net profit of \$3,881 on the PDC. The expenses for monthly meetings went down because we did not have as many members attend luncheons. With lower attendance, we did not spend as much in subsidies. (We subsidized \$9 per member per meeting and had three random free lunches.) All other revenues and expenses were about the same as the prior year.

The Dallas Chapter's fiscal year ends at the close of business on the 31st day of May of each year. The ending balance in all accounts (savings, checking, and PayPal) as of May 31, 2012, was \$21,425.

#### **Retaining Members and Attracting Young Professionals**

The Dallas Chapter membership numbers have decreased over the past few years. During 2011-12, the Dallas Chapter lost 18 members. As government financial management is not a top career choice among students and as baby boomers retire, the Dallas Chapter recognizes the importance of attracting young professionals.

#### Increasing Number of Certified Financial Management (CGFM) Professionals

The Dallas Chapter membership did not grow by new CGFMs in 2011-12. In order to increase the CGFM members, the Dallas Chapter will encourage and support the members to pursue the CGFM designation. CGFM study materials will be purchased to share among members. Study groups will also be formed to facilitate cooperative learning.

#### Offering Quality Education

The challenge remains in providing quality education and training in a cost efficient manner as budgets continue to shrink. Since educational support is a way to attract and retain professionals, the Dallas Chapter strives to offer quality education and training opportunities at affordable cost by seeking out quality speakers, and professionals willing to share their knowledge with our members.

# Raising Public Awareness of Government Accountability, Transparency and Performance

The Dallas Chapter played a limited role in promoting AGA Citizen Centric Reporting (CCR) as the position for the Accountability Outreach Coordinator remained vacant during 2011-12. Now that the position is filled, the Accountability Outreach Coordinator will be responsible for meeting with local leaders on the AGA CCR initiative.
