**Community Service Events:**

- Provided a donation for the National PDT Community Service Raffle in July 2018 in Orlando, Florida.
- July – August, 2018 – Collected cash donations for the Alzheimer's Association. This organization's mission is to eliminate Alzheimer's disease through the advancement of research; to provide and enhance care and support for all affected; and to reduce the risk of dementia through the promotion of brain health. Total contributions, including Des Moines AGA and national AGA matches totaled \$1,771.50. Several members walked in the August 2018 Walk to End Alzheimer's event held at the State Capitol in Des Moines.
- September – October 2018 – Collected donations of cash and supplies for AHeinz57, which is a foster-based animal rescue organization, headquartered in De Soto, IA. They exist to bridge the gap between traditional animal shelters and no-kill rescues by providing free transportation and temporary housing for dogs from traditional shelters to no-kill rescues and by pulling dogs out of traditional shelters and placing them in foster homes and forever homes. Total contributions, including Des Moines AGA and national AGA matches totaled \$684. Chapter members and guests donated numerous other items including paper towels, newspapers, blankets, dog and cat food and treats, pet collars and leashes, peanut butter, bleach, garbage bags, and sterile gloves. All contributions were dropped off at the AHeinz57 location.
- November – December 2018 - Collected cash donations for the Youth Emergency Services and Shelter (YESS) Their mission is to change lives by protecting children and empowering families. YESS is Iowa's largest emergency shelter for children with emergency shelter, crisis nursery care, mental health counseling, and care coordination. Total contributions, including Des Moines AGA and national AGA matches totaled \$650.
- January – February 2019 - Collected donations of cash and food and household items for the Food Bank of Iowa. Their mission is to alleviate hunger through food distribution, partnership and education. Total contributions, including Des Moines AGA and national AGA matches totaled \$596 plus over thirty pounds of canned items, peanut butter, boxed cereal, and pasta were collected and dropped off at the Food Bank.
- March – April 2019 – Collected donations of cash for Everybody Wins! Iowa. Their mission is to increase children's success in school and life through one-to-one reading and mentoring experiences with caring volunteers. Donations go towards purchasing books and supplies at each location, books for gifts for children to build a home library, and background checks for volunteers. Total contributions, including Des Moines AGA and national AGA matches totaled \$736.

- May - June 2019 – Collected cash donations for East Side Family, Inc. (ESF). This organization is a community organization focused on uplifting, educating, and feeding the youth in Des Moines. In April 2016, ESF became a non-profit organization with a mission to help someone in need. ESF believes that hunger is a root to many problems and if ESF can feed, educate, and uplift people to help change lives ESF is willing to do that. Total contributions, including Des Moines AGA and national AGA matches totaled \$672.
- Total impact to these six charities for 2018-2019 was \$2,126-chapter member and guest donations, \$600-chapter match, and \$2,383.50 requested National Community Service Fund match for a total financial contribution of \$5,109.50 plus the donations of items to the Food Bank of Iowa and AHeinz57 Pet Rescue and Transport.
