

What is your current job title? Supervising Senior - Assurance, EY

What is your current position in the Guam chapter?

President-Elect

How did you get involved with AGA?

As a student and a member of the Junior Accountants Society at the University of Guam (UOG), I participated in a few events that were sponsored by AGA. But it wasn't until I graduated and started working that I would attend meetings, though I didn't become an official member until a few years later.

What do you like most about AGA?

I like that it provides a venue to meet up and network with others in the profession and from all fields (government and non-government) and experience levels. The Guam Chapter meetings usually have a speaker that presents on matters of interest, both directly relating to work and also in our community. AGA also provides an opportunity to give back to our community and just have fun.

What do you love most about your job? I love the challenge of the job – from working

with clients and figuring out their transactions to adapting to the ever-changing environment and having to learn new tools. I took a financial statement analysis class while at UOG and actually enjoyed trying to figure out how a company is doing through their financial records.

What lesson at work has had the most impact on you?

Life is ever-changing and this applies to work as well. When I first started auditing, we were doing paper-based audits, which transitioned a desktop workspace to the current web-based, real-time platform where we are completely paperless. Our testing went from being limited to the reports that clients could provide to using data extraction tools to do 100% testing over an entity's journal entries through data analytic tools. Things are changing constantly and if you are not able to keep up with the changes, it could be difficult.

What is the most rewarding part of your job?

I find it most rewarding when I'm able to connect with those I'm working with – whether it be helping a client improve on a process or understand a new accounting concept or having a breakthrough with my audit team and solving an issue. But also the little wins when numbers balance after working at an transaction for a bit of time.

After a long day, how do you unwind?

Spending time with my son and seeing how he's growing makes all the hard work worth it.

What is your current personal goal?

When I first started working, I focused so much on putting my hours in that I didn't take the time to get my certifications. It's one of my biggest regrets and I hope to be able to find that balance between work, being a mom and being able to further my career through personal development.

Please describe your leadership style/ philosophy.

I'm more of a stop, listen and understand those I lead type in order to know their strengths and how they can do their best in achieving our overall goal. When individuals feel they are part of the team and see how their actions have an impact, I think it encourages them to take more initiative, provides motivation and a purpose to strive to do better with the team.

What's the best advice you ever received?

A friend who saw how much time and effort I was putting into work reminded me to think about what was most important to me and while work is important, not to let it consume me.

What has been your greatest challenge?

How did you overcome it? I struggle with finding my work-life balance. As a parent, it is hard to put in the long hours I'm used to doing to get tight deadlines completed, so project management has been key to staying afloat. I still have moments where work will cut into family time and the situations will always be different, so I'm learning to focus on what is a priority to me at that time.

What is one message you would like to share with AGA members?

I've been a member of AGA for several years now, but I find that I get the most out of it by being active. You don't necessarily need to hold a leadership position but participating in more than just the meetings helps you to get there. As your incoming president, I'm hoping we, as an organization, are able to get to know each other more and use AGA as an avenue to connect professionally and personally.






Lead! 2019 - West (Continued)

Presentations and intensive roundtable discussions the following day and a half provided many helpful ideas and tips for chapters to strengthen their leadership skills and provide better member experiences.

The following are a few of our takeaways from Lead! 2019 - West:


- Louise Burnette, Chapter Services Manager: Chapters are the "secret sauce" to membership doing everything right.
- Ann Ebberts, Chief Executive Officer, announced that the national governance structure has been streamlined based on members' feedback to simplify and enhance communication, and goes into effect in the upcoming fiscal year. She recapped Donny Shimamoto's article titled "Is Artificial Intelligence a Threat to Government Accountants and Auditors?" in AGA's Journal of Government Financial Management Winter 2018-19 issue. (Both were guest speakers at the Hawaii Chapter's Government Professional Accounting Seminar in September 2018.)
- Ernest Almonte, National President-Elect, introduced himself and spoke of the fast pace of change, and how chapters could help their members learn and develop new skills to adapt to these changes. He wrapped up his presentation suggesting we work on our own skills first and then reach out and helping others improve theirs.
- Bobby Derrick, Field Representative and Chapter Consultant, addressed effective communication and how different personality types affect interactions and chapter executive committee meetings (CEC). He shared the following quote and tips:
 - Henry Ford said, "Coming together is the beginning. Keeping together is progress. Working together is success."



- Secrets to successful volunteer leadership include enrolling the CEC members in the vision, remembering that goals without strategies lead nowhere, listening for underlying messages, understanding what makes people tick, sharing the power (by delegating which shows your trust and confidence in members), learning from the past, and celebrating and acknowledging success.
- The first rule of management is delegation. The benefits include saving time, helping us achieve more, relieving some of the stress, and increasing our value.
- With passion and commitment and by working together, we can achieve outstanding success.
- If your dreams don't scare you, they aren't big enough.
- Kim Jones, CGFM and Education Programs
 Manager had these tips and a quote on sharing AGA involvement:
 - Don't sell something you don't like. If you enjoy it (AGA), share it. Introduce them to an organization that can help them.
 - ♦ Have enthusiasm.
 - ♦ Share knowledge.
 - Be trustworthy.
