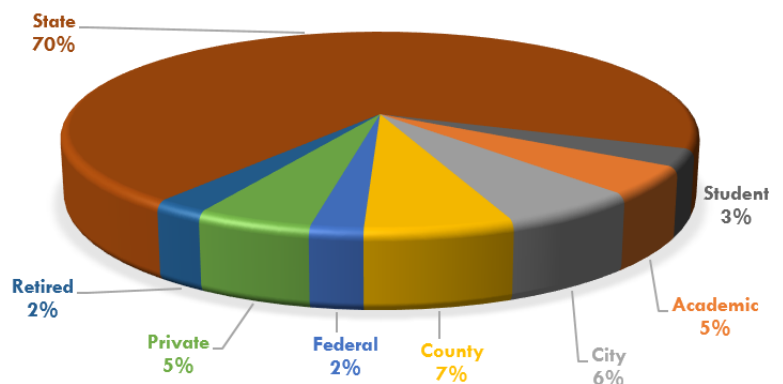

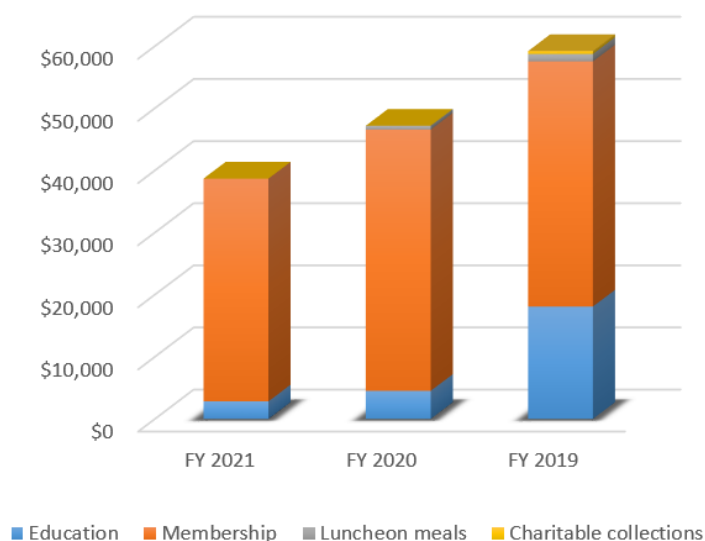

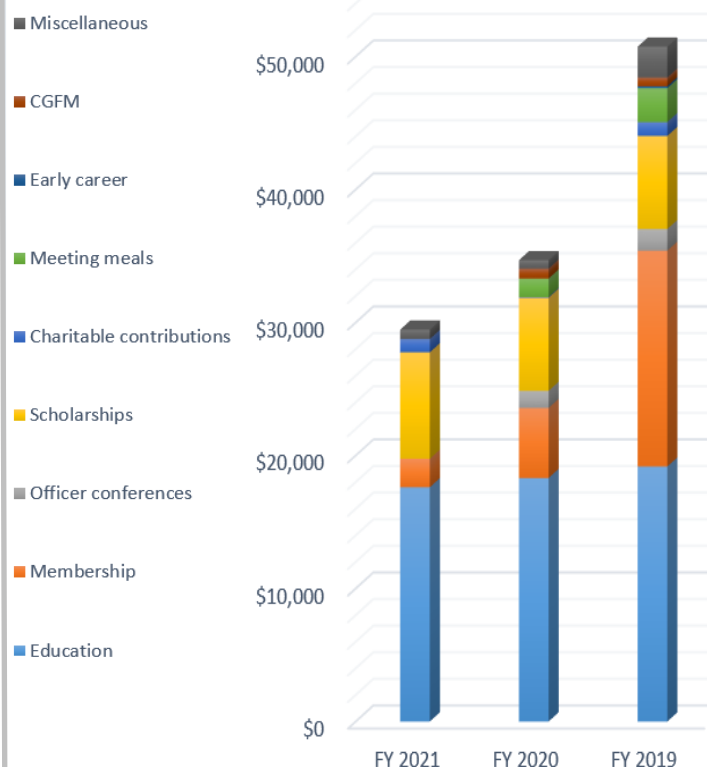

Due to the Coronavirus pandemic the Idaho Centennial Chapter's finances have changed significantly over the past few years. With many of our events being cancelled or going fully remote, costs look very different in FY2021 than they did in FY2019. Our annual Professional Development Training (PDT) event, is the most significant cost for the Board and also the most significant source of revenue. The cost to host this event virtually was a fraction of the in-person cost. As such, the cost charged to participants was also decreased. While the totals have changed significantly, revenue over expenses has remained relatively stable from FY 2019 to FY 2021 at around \$9,000
