

Volunteer Income Tax Assistance (VITA)

On December 2nd, 2015 AGA sponsored a Lunch & Learn for the Volunteer Income Tax Assistance (VITA) program. The VITA program is a national program providing free tax assistance to low income, elderly, limited English proficient, and disabled individuals who require assistance in preparing their tax returns and cannot afford services of a paid professional taxpayer. Kate McKnight (from the IRS) presented the information about the VITA program and then attendees at the meeting were able to sign up for a one day tax training class to be held in January or were given materials to complete the training online by themselves.

The tax training class was held at DFAS on January 13, 2016. The AGA Indianapolis Chapter promotes participation in VITA by linking volunteers to the program and facilitating on-site training. AGA is able to coordinate with DFAS and the IRS to be able to provide an instructor and materials free of charge to the volunteers. Kate McKnight (IRS) instructed the class on advanced returns, the Health Care Savings Account, tax laws, and how the Affordable Care Act is impacting returns.

It's not too late to become a VITA volunteer! If you missed the tax class you can still take the online training and test by yourself. March is CGFM Month!

To recognize the CGFM Program and its accomplishments, AGA has declared the month of March of each year as "CGFM Month." Your chapter is working to have CGFM Month recognized by local government, with an official proclamation being available in late March.

What is CGFM?

Certified Government Financial Manager® (CGFM®) is a professional certification recognizing the unique skills and special knowledge required of today's government financial managers. It covers governmental accounting, auditing, financial reporting, internal controls and budgeting at the federal, state and local levels.

To earn the CGFM, individuals must apply for the CGFM program and meet the following requirements:

- Ethics read and agree to abide by AGA's Code of Ethics
- · Education have a bachelor's degree from an accredited college or university
- Examinations pass three comprehensive CGFM examinations
- Experience have at least two years of professional-level experience in government financial management

How do I get the CGFM?

CGFM Certification Process

- Step 1 Read AGA's Code of Ethics
- Step 2 Apply for the CGFM Program
- Step 3 Submit Required Degree Documentation
- Step 4 Receive an Eligibility Letter
- Step 5 Submit a Work Verification Form
- Step 6 Prepare for the CGFM Examinations
- Step 7 Schedule the CGFM Examinations
- Step 8 Take the CGFM Examinations
- Step 9 Receive CGFM Award Letter
- Step 10 Receive Your CGFM Certificate and Maintain Your
 Certification

How do I maintain the CGFM?

Maintaining CGFM Certification

To retain the CGFM certification, all CGFMs must adhere to the AGA's **Code of Ethics**. In addition, to continue using the CGFM designation after their name, CGFMs must be in an active status.

Active Status

To maintain the CGFM certification in an active status, CGFMs are required to:

- · Pay the CGFM renewal fee by the due date every year.
- Complete at least 80 hours of Continuing Professional Education (CPE) every two
 years in government financial management topics or related technical subjects
 (within the designated two-year cycle).
- Maintain and, if requested by AGA, provide detailed information on CPE hours completed.

By submitting their annual renewal <u>payment</u>, <u>CGFMs</u> <u>affirm</u> that they have and will continue to abide by AGA's **Code of Ethics** and that they have fulfilled the **minimum CPE Requirements**.

CGFM Examination Requirements

The three comprehensive examinations that make up the core requirement of the CGFM program are:

- Governmental Environment (GE)
- 2) Governmental Accounting, Financial Reporting and Budgeting (GAFRB)
- 3) Governmental Financial Management and Control (GFMC)


CGFM Examination Sample Question:



Be the Leader You Want Your Boss to Be

I'd just finished a leadership program with a group of caring, committed professionals. They asked great questions, made important decisions, and then it happened. A middle level manager approached me and asked a question. It's a common question. I hear it every time I speak—in the Q&A, in the comments afterwards, in emailed follow-ups. This manager asked, "David, I really appreciated the program today. How can I get this information in front of my boss's boss?" If you've ever read a book, attended a seminar, or heard a speaker and desperately wished your supervisors would learn how to do what you just heard, you're not alone.

In fact, the phenomenon is so common that I've given it my own name. I call it SASRNT Syndrome—So And So Really Needs This. It's the reaction you have when you encounter really good information and immediately want to give it to someone else. "This is awesome. My boss totally needs this!"

There's just one problem: your boss didn't receive the information. You did.

Don't Fail Before You Start I call SASRNT a syndrome because it can hurt you if you let it. When you rush off to share good leadership information with someone else, you neglect the most important step: to use it. That other person—your boss, your colleague, your spouse—may need...
