### **Our Community**

Originating as Newport in the late 18th century along the confluence of the Ohio and Little Kanawha Rivers, the town area was laid out following the American Revolutionary War on land granted to Alexander Parker for his war service. The area was renamed Parkersburg for him in 1810. The city developed into a transportation and medical center for union forces during the civil war. Parkersburg continued to gain prominence as a transportation hub during the oil and gas boom of the late 19th Century. Today, one of the attractions our city is known for is Blennerhassett Island – a national historic site located just south of downtown in the middle of the Ohio River.

Parkersburg (and the greater Mid-Ohio Valley) is home to multiple employers in industries that include manufacturing, oil and gas exploration, plastics, a regional health care system, and government operations. These model employers have long recognized the talent and strong work ethic of our region and have located significant operations here with an influence in our world economy. Our local schools, trade schools, and colleges are all above average and this prepares and sustains a workforce ready to support growth and opportunities.

Parkersburg has a long history of supporting the small-town atmosphere by creating a thriving and welcoming community. The beauty of this region, with lakes, rivers, and rolling hills, offers many occasions to enjoy recreational, historical, and cultural pursuits. We have the workforce, infrastructure, and educational opportunities to continue as an integral part of the evolving 21st Century.






# CHAPTER FINANCES

## **Revenues** and Expenses


The chapter is a 501(c)(3) organization that is comprised of voluntary board members and committee chairpersons. We raise money by offering training courses, CPE credits, hosting dinner meetings, and obtaining sponsorship. The revenues that we receive from these sources are used to pay the costs incurred, and excess funds are held for future use. Our chapter hosts a Spring Forum every other year, and we also offer the CGFM courses every other year.
