



Mission

The New Mexico Chapter serves professionals in the government financial management community by providing quality education, fostering professional development and certification, and supporting standards to advance government accountability. The New Mexico Chapter mission is to provide or sponsor appropriate educational programs, encourage professional development, influence governmental financial management policies and practices, and serve as an advocate for the profession.



Community Service

In 2013 the Chapter joined the Making Strides (Breast Cancer Awareness); and collected donations for Santa Fe Youth Shelters and San Martin de Los Porres Soup Kitchen. New Mexico AGA also teamed up with San Antonio AGA Chapter to sponsor "Wreaths Across America" to recognize our fallen heroes by placing wreaths at the Santa Fe National Cemetery.



Education

The objective of the New Mexico Chapter is primarily to instruct, train and inform government financial professionals in the fields of accounting, auditing, budgeting, systems and financial management. Representatives from all areas of government and those that work closely with governmental entities attended the 2014 Annual Professional Development Conference (PDC), *Shared Solutions for Effective Management*. The 2014 PDC had an attendance of 140 members and non-members, the educational topics offered were in the following areas:





Financial Accountability and Transparency

The New Mexico Chapter has the following controls over financial transactions:

- AGA New Mexico Bank Account with the Past President, Current President and President-Elect on the account
- Check Register maintained by the Treasurer, and provided to the Chapter Executive Committee (CEC) for review
- The President calls for a poll vote on any type of financial transactions
- The New Mexico and Albuquerque Chapters work jointly on an annual Professional Development Conference and Membership Appreciation Events. The New Mexico and Albuquerque Chapters share equally in the expenses and revenues for shared events. The New Mexico Chapter CEC reviews and votes any shared expenses between the chapters.
- The 2013 –2014 CCR has been reviewed by the CEC prior to submission.
