




## **Revenue and Expense Comparison**



The majority of the revenue and expenses for the Chapter are attributable to the annual PDT. The New Mexico and Albuquerque Chapters have a joint PDT and share equally in the revenues and expenses. The presentation above is based on the same year-end as the 990 Tax return, March 31.

Payments made by the Chapter are sent to the CEC for approval. The Chapter Treasurer prepares the financials and the bank reconciliation for CEC review on a monthly basis. The 990 tax return is reviewed and approved by the CEC prior to submission.

## 2016 Professional Development Training Financial Summary



The pie chart is a the break-down of expenses categories for the 2016 PDT. Attendance was down by a third from 2015. But the overhead costs like paying for speaker travel, providing meals to speakers and AV equipment did not decrease.
