# Testing Aspects of a Mature Control Environment Efficiently

Government entities are evolving and becoming more mature as they complete remediation activities, enhance control activities to reduce risk of misstatement, consider operational controls, and fully document their control environments. With this maturity comes the ability to further understand, document and test complexities in their control environment, like Information Used in Controls (IUC) (also known as Information Produced by Entity (IPE)) and how to monitor internal and external service providers. Further, information system environments are also maturing, and entities are finding that they may be able to rely on Information Technology General Controls (ITGCs), allowing for the consideration of the application layer, and application controls.

#### **Learning Objectives:**

This webinar will provide a discussion about how government agencies evolved from standard internal control documentation and testing, to building integrated approaches that allow internal control testing teams to dig deeper, identify further risk, and aid in the further evolution of processes to promote sound internal control.

- Internal control programs should not be designed in silos. There are
  efficiencies that are understood when you understand the connection points in
  your control environment, and how your control activities rely on different
  nuances.
- Internal control testing is not a check the box activity and it is possible to
  evolve past the standard Test of Design and Test of Effectiveness, to integrate
  further testing for more informative results about where deficiencies or
  weaknesses in your environment may exist, better informing management's
  understanding of risk and ability to take action.
