I have performed the procedures enumerated below which were agreed to by the Board of the Phoenix Chapter of the Association of Government Accountants solely to assist the Chapter Members (the specified parties) in evaluating the Chapter's procedures as of and for the FY2015 and FY2016. The Chapter's management is responsible for the organization's accounting and reconciliation procedures related to the Phoenix Chapter.

Cross checked and verified the accuracy of Activity Detail (Receipts and Disbursements) Report with deposit report and the monthly Bank Statement by assuring that all supporting documents have been properly attached.
