## NLT National Collegiate Leadership Program

The 2020 National Collegiate Leadership Program will provide students with an opportunity to engage with and learn from leaders in government financial management at AGA's National Leadership Training (NLT) in Washington, D.C., Feb. 12–13, 2020.

AGA will select up to 10 students to attend NLT 2020. Awardees will receive a scholarship to cover lodging and airfare (if outside of the D.C. Metro area). AGA will coordinate all travel arrangements through its own travel service provider. Application deadline is **Nov. 8, 2019, by noon Eastern Time**.

### National Collegiate Leadership Program Awardees will:

- ◇ Be assigned an onsite mentor who will guide them around NLT.
- ◇ Learn from experts with real-world leadership experience in government and business.
- ◇ Network with leaders who are passionate about public service and advancing government accountability.
- ◇ Meet and connect with potential employers (government and corporate).
- ◇ Receive recognition during the event, including a certificate of participation.
- ◇ Attend NLT sessions and earn continuing professional education (CPE) credits.
- ◇ During lunch, sit at reserved VIP tables with private sector and government executives.

### Applicants must:

- ◇ Sign up for a student membership — [agacgfm.org/join](https://www.agacgfm.org/join).
- ◇ Complete and submit the application on or before Nov. 8, 2019.
- ◇ Be a Junior or Senior accounting, finance, information security/technology, or business major, having completed 60 credit hours (or equivalent).
- ◇ Submit a letter of recommendation from a faculty member.
- ◇ Have at least a 3.2 GPA.
- ◇ Display leadership experience on campus or through another affiliation.

# What is CGFM?



Certified Government Financial Manager® (CGFM®) is a professional certification awarded by AGA, demonstrating competency in governmental accounting, auditing, financial reporting, internal controls and budgeting at the federal, state and local levels.

## What are the initial requirements?

To earn the CGFM, individuals must apply for the CGFM program and meet the following requirements:

[Ethics](#) — read and agree to abide by AGA's *Code of Ethics*

[Education](#) — have a bachelor's degree from an accredited college or university

[Examinations](#) — pass three comprehensive CGFM examinations

[Experience](#) — have at least two years of professional-level experience in government financial management

## Maintaining CGFM Certification

To retain the CGFM certification, all CGFMs must adhere to the AGA's [Code of Ethics](#). In addition, to continue using the CGFM designation after their name, CGFMs must be in an active status.

### Active Status

To maintain the CGFM certification in an active status, CGFMs are required to:

- Pay the CGFM renewal fee by the due date every year.
- Complete at least 80 hours of Continuing Professional Education (CPE) every two years in government financial management topics or related technical subjects (within the designated two-year cycle).
- Maintain and, if requested by AGA, provide detailed information on CPE hours completed.

By submitting their annual renewal payment, CGFMs affirm that they have and will continue to abide by AGA's [Code of Ethics](#) and that they have fulfilled the [minimum CPE Requirements](#).
