#### Session 1 – Topic: "What is Accountability?", Speaker – Suzanne Bump, National AGA Director-At-Large



The Honorable Suzanne Bump just concluded a 12-year tenure as Massachusetts' elected State Auditor, the first woman to hold this position. Having previously served as a state representative and cabinet secretary, Auditor Bump has consistently shown herself to be dedicated to effective and efficient state service. As State Auditor, she conducted performance audits and public assistance fraud investigations, and reviewed privatization proposals and state mandates on local governments, and served on numerous other state agency boards.

Taking office after a failed peer review, she made auditing excellence a priority and instituted a wide range of programs that promoted professional development, quality control, and the deployment of new technologies. Her efforts resulted in award-winning reports in Medicaid auditing and police training assessment, as well as in IT development. They also identified more than \$1.5 billion worth of improper payments and prompted major administrative and legislative reforms in special ed collaboratives, Medicaid administration, child welfare, veterans' services, public safety, and regional transportation funding.

Auditor Bump currently serves on AGA's national governing board, and she is a past president of the National State Auditors Association. She is graduate of Boston College and Suffolk University Law School.

#### Session 3 - Topic: Workers' Compensation Law Speaker - Mark S. Setaro, Weber Gallagher, LLC

Mark is certified by the New Jersey Supreme Court as a Workers' Compensation Law Attorney; and, is a Fellow in The College of Workers' Compensation Lawyers, a nationwide organization that honors workers' compensation practitioners, educators, and judges nationwide.

Mark has achieved a Distinguished Rating from Martindale-Hubbell. This is given to attorneys who has experience and is widely respected by their peers for their professional achievement and ethical standards.

Glenn has worked for the Internal Revenue Service for 33 years. He began in Taxpayer Service in 1989 as a Taxpayer Service Specialist answering account and tax law questions on the IRS's toll-free phone line until becoming a Revenue Agent in 1994. During his 11 years as an Agent, Glenn worked in the Examination Problem Resolution Unit as a caseworker, a cooperating Agent for Criminal Investigations and was a Taxpayer Advocate at the model walk-in office in Edison. Glenn is also a certified instructor for the IRS and has spent four years training the new incoming Revenue Agents from 2001 to 2005.

Additionally, Glenn worked in the former Taxpayer Education & Communication division during its stand-up in 2001 before it was eventually realigned into Communications & Liaison. His current assignments include the Annual Federal State Tax Workshops, North & South Jersey Working Together, AARP, multilingual associations, school districts and the underserved community.
