Accomplishments

- Celebrated our chapter's 60th anniversary!
- Held our 25th annual Commonwealth PDT our first one virtually.
- Nominated 6 people/groups for individual PDT awards - Dr. Jesse Hughes won the Educator Award and Jay Poole won the Distinguished Local Government Leadership Award.
- Named an AGA Volunteer of the Year Joy Leyeza.
- Conducted a successful (virtual) spring PDT joint with ASMC.
 - 180 attendees
 - 5 sponsors
 - Attendees networked via breakout rooms.
 - Prizes awarded for active engagement.
 - Earned \$20k split with ASMC.
 - Raised more than \$5k for charity St. Mary's Home for Disabled Children.
- We held a spring community service project -GRAB A BAG - in which we encouraged members to bring up trash in their neighborhood and community....and won the national community service award!
- We obtained a proclamation from the State of Virginia for March being CGFM month.
- Held a meeting our PDT every month, including our annual student night in October, our annual joint meeting with ASMC in January, and our annual joint meeting with IIA in February.
- We reminded members to renew and encouraged new members with incentives.
 We were a winner in Membership Madness.
 We recruited 17 new members.
- We conducted a membership survey. 94% of attendees say the chapter "exceeded my expectations".
- Recruited several new volunteers for our 2021-2022 CEC.
- Communicated monthly with members through emails of upcoming events and activities.

Our Finances *Revenues and Expenses*

What are the costs for servicing our members and how are those costs paid?

The VA Peninsula Chapter held its annual professional development training conferences (PDTs) in the fall and spring, which is our primary source of revenue. Due to the COVID-19 pandemic, we had to hold them both virtually, for the first time ever. Thanks to the teamwork of our volunteers and partners and the generosity of our sponsors, both were successful events both educationally and financially. We were able to lower cost due to avoiding event and meal costs, however we still incurred credit card fees, speaker gifts, and community service donations.

For our fall PDT, we partner with three other AGA chapters: Richmond, Shenandoah, and Roanoke. We split responsibilities as well as profits by a preset percentage. As a whole, we netted \$16,714, and the VA Peninsula Chapter's share of the profit was \$5,432. Even in the middle of a pandemic, we had a good PDT.

Our spring PDT was similar. We split the revenues and expenses of the spring PDT (\$21,288) with our partner ASMC (\$23,500 minus expenses \$2,212). We supported a charity (St. Mary's home) through our speaker gifts and encouragement of attendees to donate.

By the end of the program year, we were finally able to have an IN PERSON event – our end of the year party for our members! Although the weather wasn't ideal for an outdoor beach party, we had a great turn-out and a good time. The chapter subsidized the cost of this event as a thank you gift to its members. Outside of this cost, the chapter's expenses were relatively minimal.

We plan to use the revenue we have generated in recent years to endow a scholarship that will help local students pursue degrees in government accountability. The chapter executive committee voted to approve putting \$25,000 towards this effort, dependent on how well our 2021 fall PDT does to ensure it doesn't drop our bank account balance below \$20,000.

Independent Audit

Brad Smith and Gail Williams, chapter members, conducted an independent audit of the chapter's finances and provided recommendations for improved internal controls which the chapter incorporated into its financial policies and procedures.

What's Next? Key Initiatives

Rebuild and Remake Ourselves in the Face of a Pandemic

The chapter continues to rebuild after the COVID-19 pandemic grinded to a halt chapter operations in March 2020. The AGA VA Peninsula Chapter had a significant number of members, including chapter leaders, not renew their membership. Given the ongoing safety and health concerns, we held all our meetings and education events virtually, which allowed us to offer monthly chapter meetings free to our members. We continue to reach out to our lapsed members in hopes of getting them to rejoin, and we are looking to attract new members and retain our members by offering significant value in the way of CPEs and networking opportunities.

2021-2022 Chapter Goals:

Our goals for the coming year include:

- Membership growth: 10% (We have 153 members as of August 2020, this would require 15 new members)
- Overall Membership Satisfaction: 75% satisfaction (meets or exceeds expectations)
- Training Events: Offer 34 hours of CPE (14 hours of fall PDT, 14 hours of spring PDT and 6 monthly meetings). We are planning time for networking 10 minutes before each virtual meeting.
- Educational Meeting Attendance: 150 average attendance for fall and spring PDTs. 25 average attendance for meetings.
- Educational Meeting Satisfaction: 75% satisfaction (meets quality expectations) as measured by polls at monthly meetings.
- CGFM Candidate Support: We plan on continuing our study guide loaner program and retain 80% of our CGFMs.
