**Robert W. King**  
**Founder and First Chapter and National President**  
**1950-1951**

At the invitation of Robert W. King, a group of 21 federal accountants met in May 1950 to discuss the need for a professional organization for federal government accountants. At the group's request, he chaired the working committee that established the organization.

Under his leadership, the first meeting of the "Federal Government Accountants Association" was held in September 1950. Membership certificates were issued to the 59 Charter Members. (The name of the association was changed to AGA in 1975.)

Robert King wore two hats, as both DC Chapter President and National President in 1950-51. He served again as National President in 1956-57.

**In 1975**, AGA expanded to include state and local government finance professionals.

**In 1978**, AGA's National Executive Committee voted to approve full membership for private-sector and retired practitioners.

**In 1980**, AGA National Board of Directors ratified a bylaws change to eliminate the requirement that top AGA officers be active government employees.

**In 2013**, AGA DC chapter members voted to approve the chapter bylaws with no requirement for the Chapter President to be a government employee.

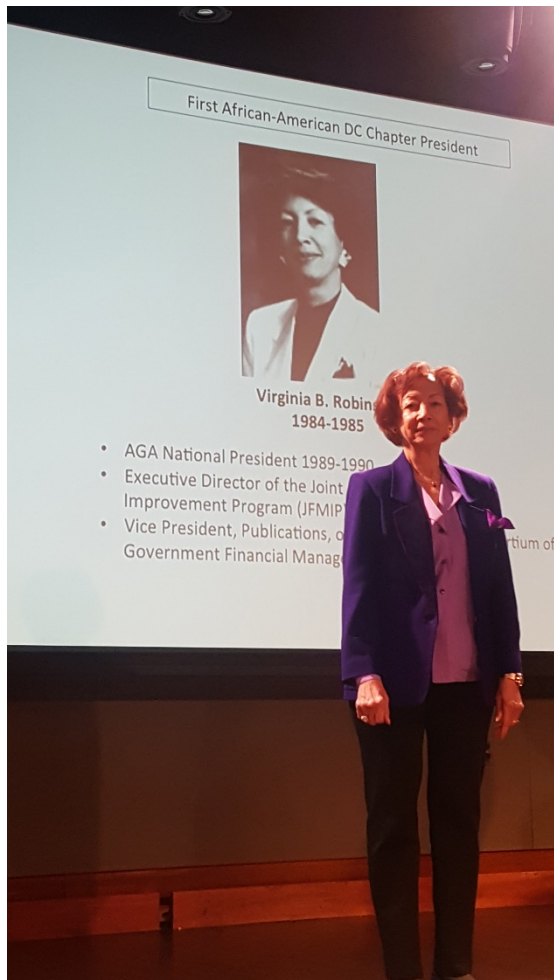
