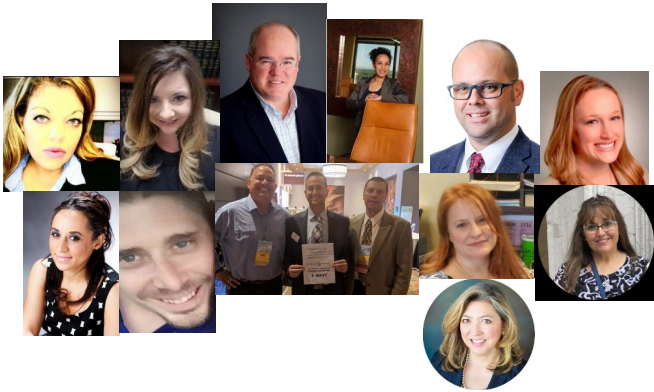


Report to Our Members 2019—2020 Citizen Centric Report (CCR)



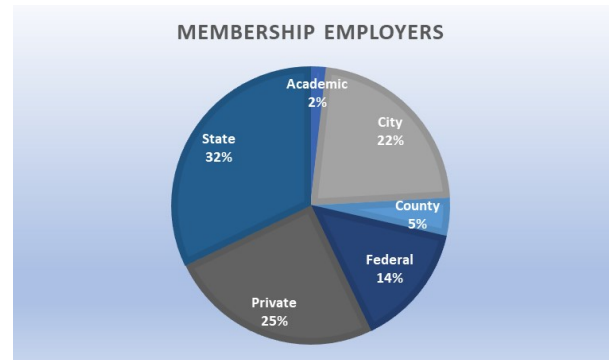

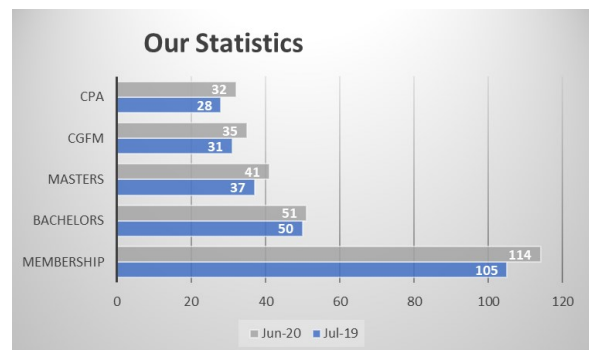

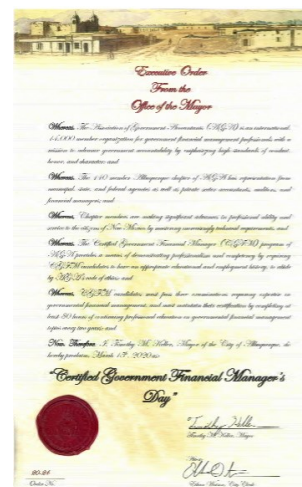

The City of Albuquerque received a Certificate of Excellence for the 2019 CCR. The Accounting Division, and our CEC member Pam Fanelli led the way in being recognized by Mayor Tim Keller “From bringing transparency to the management of taxpayer dollars to a major overhaul of our public records systems, we’ve made breaking down the barriers around City Hall a core issue. This national recognition of our efforts to make information more accessible to the public shows that we’re on the right track. I’m proud of our financial team’s efforts as we make city government more open than ever.”

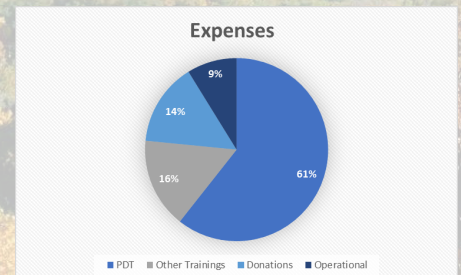
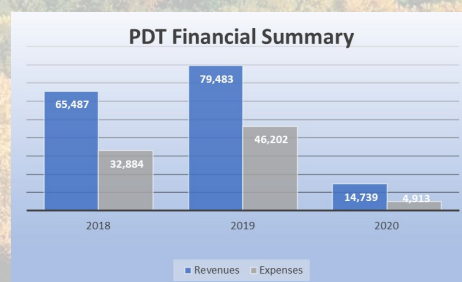
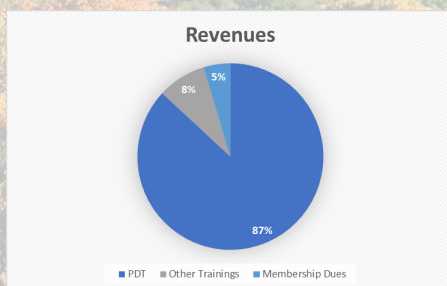


Chapter Finances

The biggest source of revenues and expense for our chapter is the joint Professional Development Training (PDT) with the New Mexico Chapter. The chapters did not have sufficient time to plan a virtual training, so the PDT was postponed to April 2021.

The majority of the revenues and expenses are related to the 2019 PDT. The revenue from the PDT allow the chapter to offer CPE during the year at no cost or low cost to members.

Our training year ended earlier than planned due to the restrictions related to COVID19, but we were still able to offer five training sessions totaling eight CPE.

Looking to Next Year!

Our chapter ended the program year on a happy note, with four national awards. The beginning of the program year brings new challenges of meeting our goals while keeping our members safe. We now have a virtual venue to offer our training and we brainstormed of ways to keep our attendees engaged. Our goals for the program year 2020-2021 are as follows:

Goal 1: To maintain membership and add 7 new members for the program year. Of the 7 members, would like to add 3 new student members to AGA. We added one student member, she is also on the CEC.

Goal 2: Collaborate with NM Chapter to offer an engaging 2021 PDT for our members. We have a virtual venue that will allow 500 attendees. We hope the virtual PDT will help with our goal to increase membership.

Goal 3: Provide 36 CPE with a full calendar that includes seven training sessions, three national webinars and a joint PDT with the New Mexico Chapter offering 16 CPE. The CEC will team-up to ensure the local sessions are effective and stimulating CPE facilitated by our local professionals.

Goal 4: Encourage member participation (*virtually*) in networking socials and community service activities.

Goal 5: Celebrate 4 members on the successful completion of CGFM Certification.
