

Revenue increased by 20% in 2020. This is primarily due to the seminars offered in October 2019.



The foundation of the CGFM is the requirement for Education, Experience and Examination. Building on this foundation is a Code of Ethics and required Continuing Professional Education (CPE). This designation is already recognized as a professional standard. Each year, more and more federal agencies and state and local governments are realizing the value of the CGFM and are formally embracing the designation. It is often listed as a preferred hiring qualification on federal RFPs.



Get CGFM Certified Today!

The Certified Government Financial Manager (CGFM) is a professional certification awarded by AGA. It demonstrates competency in governmental accounting, auditing, financial, reporting, internal controls and budgeting at the federal, state and local levels.

The Chapter will continue to offer CGFM scholarships each program year to aid in the cost of exam fees. The Chapter also plans to offer CGFM review courses to be presented by current CGFM members.
