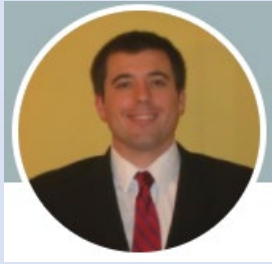

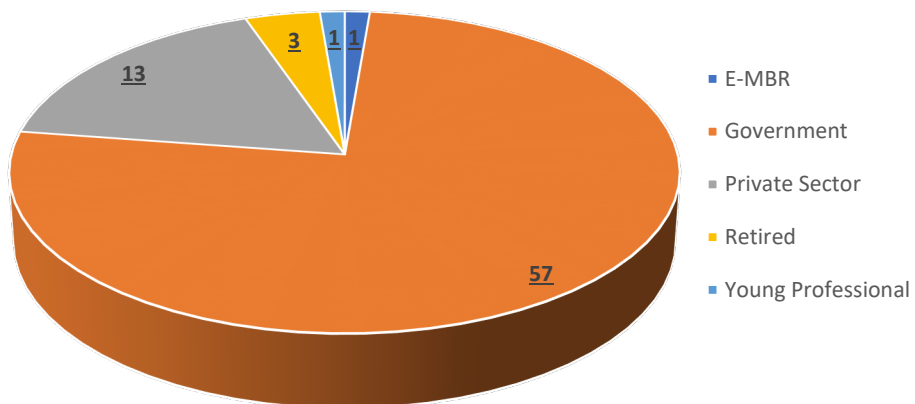

Membership Statistics (Pie Chart - Source of Membership-State, Local, Federal, Student, Other)

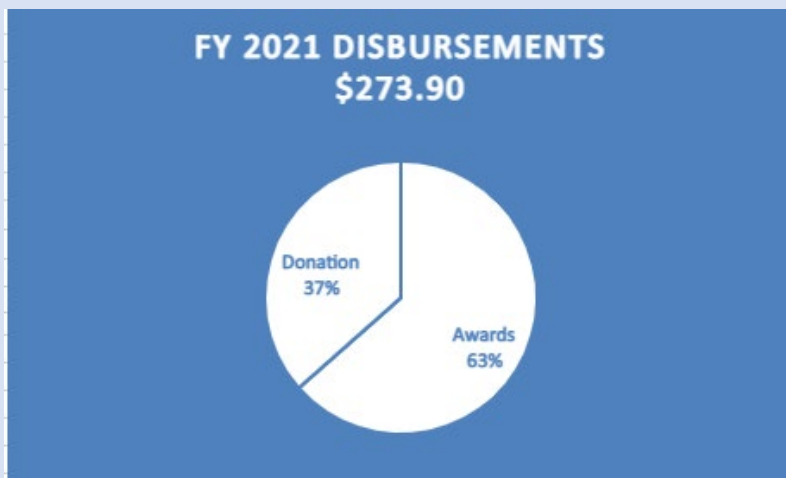
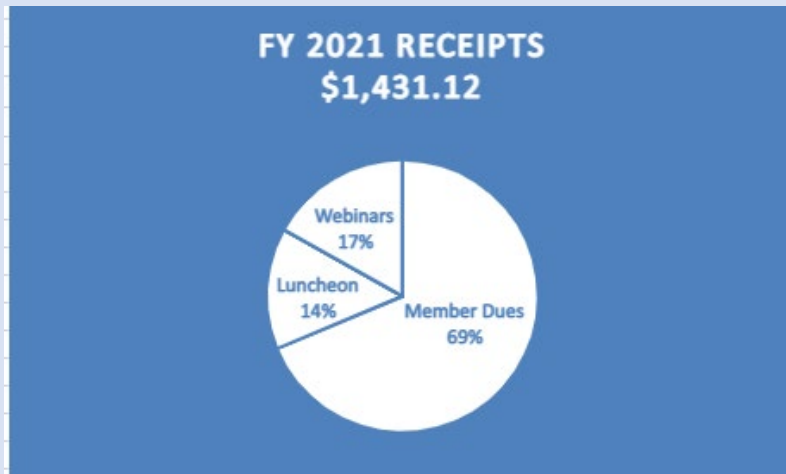
