

Fiscal Year Financial Summary

The COVID-19 had a definite and observable negative impact on the finances of the East TN Chapter. Several factors contributed to decline in revenues and the requisite increase in expenses as a percent of total revenues.

Membership dues as a percentage of Total Revenues increase significantly from 4% to 22% where chapter meeting revenues declined to 0%, and chapter PDT revenues declined from 90% to 78% of total fiscal year revenues. The decline in total revenues was \$15, 313. The drop was attributed to several factors including a decline in the number of registrants from 55 to 26 and a reduced registration fee. The Chapter Meetings' revenue declined to zero because a charge was not assessed for any of the chapter meetings. The membership dues increased; this was attributed to an increase in membership of ten new persons to the chapter.

Expenditures expressed as a percentage of total revenues increased across the board. The number of persons attending a National PDT and AGA LEAD totaled seven in the current period. The investment in leadership accounted for 45% of the total revenues raised. The chapter PDT reflects the cost of using the virtual platform and the honorariums given to speakers. Chapter operations costs were higher as a percent of total revenues due to the cost of a virtual platform to deliver professional education content. Finally, despite the decline in revenues, the East TN donated at a higher percentage of total revenues in contrast to the prior year.

The financials tell the story of a fiscal year riddled with challenges. This upcoming year, there are plans in place to counteract the drop in revenues and to boost engagement of membership. The plans are captured in the Strategic Plan for the East TN Chapter.

SOME HIGHLIGHTS FROM OUR STRATEGIC PLAN

We plan to accomplish these goals in the upcoming year: 1. Achieve an increase in our base membership by 10% but will strive to exceed a 10% growth.

2.Exceed 80% membership satisfaction as represented in a survey.

3. Hold one virtual conference in the Fall and eight monthly meetings (at least five providing CPE) that include a networking and a lunch opportunity. Maintain an average of 30 members at meetings and 50 at the Fall conference.

4.Offer meetings in a hybrid format to reach a broader audience.

- 5. Maintain our 4 out of 5 average on satisfaction surveys.
- 6.Support CGFM candidates with provision of study questions, encouragement, technical requirements, information on upcoming virtual review sessions. Provide a CFGM exam gift or reward to persons pursuing the certification.
- 7.Continue to refresh the website and send out monthly newsletters. Assign specific responsibility to a CEC member to create and maintain media accounts.
- 8. Support KARM (a local NFP providing services to the homeless) and invite the organization to present at our December meeting. Host a fundraiser for this cause and participate in Angel Tree/Adopt Family program.
- 9. Continue to bring on new CEC Members and recruit Young Professionals for leadership roles.

10.Continue to recruit student and professor memberships
