
Why Have We Built G-Invoicing?

Treasury Is Committed To:

- Ensuring Citizens will be able to see their government's finances in a single understandable financial statement with a clean audit opinion.
- Working toward a clean audit opinion by providing agencies with an automated method for reporting interagency buysell transactions — a major source of today's audit failing.

Treasury Will Strengthen Financial Reporting By:

- Automate inter-agency buy-sell transactions
- Make federal financial data more accessible








Modernizing Our Development Approach

A Federal Intra-governmental Data Standard (FIDS) which must serve as the foundation for the process and policy standardization activities



Clarify, enhance, and create guidance relating to IGT Buy/Sell processing, accounting and reporting

Standardized system solution where Federal Trading Partners can broker and exchange information in support of common accounting treatment

G-Invoicing is not just an application, it's a solution.

A solution which unites Federal Trading Partners, provides transparency into IGT Buy/Sell transactions, and drives more accurate accounting and reporting.



Improved Intragovernmental Transaction Data Quality and Transparency

- Brokering solution requiring Trading Partner communication and agreement at each phase of the IGT Buy/Sell lifecycle
- A robust User Interface and Modern API-based data exchanges based upon a common Federal Intragovernmental Data Standard
- A transparent repository of agreed upon data that supports the preparation of timely and accurate United States Standard General Ledger (USSGL) entries by both Trading Partners



Reduction in intragovernmental buy/sell differences




Alignment to Fiscal Service's Strategic Plan:
