The City of Montgomery is the capital of Alabama and was incorporated on December 3, 1819 as a merger of two towns situated along the Alabama River. The City's goal is to continue to provide outstanding public services to its citizens; construct new public facilities where needed; and recruit new businesses as well as encourage the expansion of existing businesses. The City of Montgomery operates under a Mayor/Council form of government with a fiscal year from October 1st through September 30th. The Mayor and nine (9) Council members are each elected to four (4) year terms.

The City provides police and fire protection: emergency 911 services; sanitation services; construction and maintenance of highways, streets, and infrastructure; public parking facilities; recreational activities and cultural events.





Revenue

The increase in revenue can be attributed to **1**) sales tax revenue generated from citizens who spent their federal COVID-19 stimulus and **2**) **COVID-19 grants** from the federal and state government to assist in COVID-19 relief and mitigation efforts.

These increased revenues helped offset the **decline in lodging tax revenue** (included in Other taxes in the chart above) caused by COVID-19's impact on the tourism industry

WHAT CHANGED?

Expenses

Before COVID-19, the City was utilizing resources efficiently and in response to the pandemic, **departmental spending was further restricted** leading to lower expenses. A **decrease in public services and activities** due to the pandemic and the **transition of the retirement plan** to the Retirement Systems of Alabama also

helped reduce costs.

Personnel costs increased but were less than budgeted due to the inability to fill and maintain budgeted personnel positions and through attrition in 2020.

Net Position

The City's net position for FY 2020 is **\$505,139,891** - an increase from the previous year due to a **decrease in net pension liability**.

Debt restructuring to help fund the purchase and improvements of capital assets, including the acquisition of the Garrett Coliseum also contributed to the City's **financial stability** throughout FY 2020.



An independent audit was conducted by Warren Averett, LLC who rendered the opinion that the City's financial statements for FY20 are fairly presented in conformity with GAAP. MOVING FORWARD

The City of Montgomery is working toward several goals and initiatives that not only improve Montgomery's short-term objectives but also ensure positive long-term economic growth and quality of life.

EDUCATION FIRST - Public Education Support Referendum



Montgomery currently only collects the state minimum amount allowed for property tax revenue towards public schools. With the shift in the **community's focus towards education**, Mayor Reed alongside public officials, business leaders, educators, military leaders, and many others are campaigning to pass a referendum that will **raise funds to support Montgomery Public Schools**. The funds will allow the city to strengthen STEM programs, add pre-k, AP, art, and music classes, and rehabilitate school facilities, all crucial investments in the future of our youth.

BUSINESS ADVANCEMENT - Montgomery TechLab

In partnership between the City, County, local economic development partners, IT companies, and the US Air Force, the development of the Montgomery TechLab will allow the city to **advance innovation and entrepreneurship** through education, acceleration, and incubation. By working with industry leaders, local startups will be able to provide services at their full potential. This will allow Montgomery to focus on growing the city's economy in addition to taking the first major step in **establishing Montgomery as a city of innovation**.



CULTURAL REJUVENATION - Garrett Coliseum



Since opening in the 1950s, the Garrett Coliseum hasn't gone under any significant renovation. With the Coliseum ownership transferred to the city and county and renovations in the works, the Garrett Coliseum could once again be the hub of entertainment, including concerts, football, and fairs year round with the installation of an air conditioner. The coliseum will be renovated to **bring new opportunities,** further **enhance the community**, and potentially **triple** the usual revenue of \$100 million.

LOOKING AHEAD - Envision Montgomery 2040

In 2019, Montgomery was a community in transition. To begin this change, Envision Montgomery 2040 Comprehensive Plan was created and officially adopted on July 7, 2020. The plan is made up of around a dozen topics including land use, transportation & mobility, housing & community development, public health, military, education, and many more. The ultimate goal is to not only make Montgomery prosperous but will also **help guide decision-making** in the city for years to come.
