
## WHO ARE WE?





## IMPROVING INFRASTRUCTURE

As defined in their Strategic Plan, Urbandale plans to update and implement new services by improving the City's infrastructure. This includes creating new policies that target the regional water supply and treatment and stormwater management; implementing a city-wide security system; and improving sidewalks and pavements. The COVID-19 pandemic may affect the priorities of these strategic goals as the lockdown will decrease revenues and delay the implementation of their strategic goals.



## IMPROVING THE ECONOMY

In 2017, the City of Urbandale implemented the Urban Loop Project, which aims to strategically place businesses in an area of connected and highly accessible traffic routes. There are currently nine projects in the Urban Loop that are under development or are planned to start development. The COVID-19 pandemic could affect businesses in, and development of, the Urban Loop. To combat the effects of the pandemic, the Greater Des Moines Area implemented a Small Business Recovery Grant program to support small businesses.



## IMPROVING PARKS AND RECREATION

Urbandale is home to over 50 parks and 50 miles of hiking trails that span over 1,000 acres of parkland. Urbandale continues to increase efforts to promote outdoor recreation for the community by focusing on the restoration of Creek Bank, completing construction of outdoor skating rinks and pickleball courts, and continuing their commitment to the arts in the form of public artwork. The restoration of Creek Bank and construction of outdoor recreational facilities could be delayed by COVID-19 due to potential decreases in revenues.



## URBANDALE OUTLOOK

Urbandale has consistently experienced positive economic growth in recent years and continues to further their growth through their assistance and tax incentives programs. Because COVID-19 may negatively impact this growth, the City will most likely need to reevaluate their priorities by, for example, delaying the development of the Urban Loop and other construction projects. To provide assistance and support to businesses and individuals affected by COVID-19, the City of Urbandale implemented the Greater Des Moines Partnership DSM Employment Ready initiative. This will hopefully restart the economy at a more rapid pace and minimize the negative effects of the lockdown. Additionally, should all go according to plan, the Greater Des Moines Metro Area intends to increase their population by 270,000 people and 115,000 housing units by 2050, which may bring greater economic growth to the area.
