#### **Education**

- Each fall, the COAGA presents the annual PDT Professional
  Development Training (PDT) which offers an excellent slate of
  speakers and a wide range of break-out sessions. Last year, our
  chapter provided 16 CPE hours to approximately 150 attendees in
  our first-ever hybrid event. We had 16 different speakers and a
  total of 22 sessions. Some of the notable speakers included Michael
  Glynn of the AICPA, Lisa Parker from GASB, and National AGA
  speaker Melinda DeCorte.
- The Chapter offers CPE sessions throughout the year. Each session ranges from one to eight hours and are often free to members registering in advance.

## **National Recognition**

- During this year's National AGA PDT, Central Ohio Chapter member Emily Hay was recognized as our Chapter's Volunteer of the Year.
- Central Ohio AGA members Samantha Alberts and Tiffany Ridenbaugh participated in panel presentations at the National AGA PDT Conference.

# **Giving Back to the Community**

- In 2023, the Central Ohio AGA awarded five \$1,000 scholarships to high school students entering college with an emphasis in accounting.
- In 2023 the Central Ohio AGA made a donation of \$470 to the Mid-Ohio Food Bank. Member donations totaled \$235 and the chapter made a matching contribution.

#### **Social Events**

• Throughout the year, our Chapter holds a number of social events for members and their families. In 2023 we hosted a Golf Outing at the New Albany Links. Additionally, we hosted a networking event where we invited members and guests for an evening at the baseball diamond to watch our local baseball team, the Columbus Clippers.





Our main revenue source is our annual Professional Development Training (PDT). Profits from this event are used to fund continuing education, charitable donations, community service events, and scholarships. 2023 was our first year hosting this training as a hybrid event. We do not intend to keep it a hybrid event as it is cost prohibitive but we will monitor the feedback from our members to see if it is an option we may want to offer in future years.

Our chapter had a net assets of \$69,523 in 2022. As of June 30, 2023 net assets for the COAGA sit at \$46,018. We anticipate similar expenses in the coming years as we transition back into providing an inperson PDT. Some expenses from the 2022 fiscal year were carried into 2023. We will continue to investigate alternative options to provide educational experiences in convenient locations at an affordable price to our members.

For the second year in a row, we saw an increase in our annual revenues. This was due to increased attendance in our annual PDT. We hope that our members value the training and we continue to increase attendance. Moving forward, we will need to monitor expenses related to the PDT as our expenses outweighed our revenues in 2023.


