



### Revenue 2022-23 Program Year





# Challenges and Future Plans

### **Student Engagement**

The Ozarks Chapter of AGA believes it is important to invest in our college students, the future workforce. Our chapter will continue this investment by reaching out to surrounding colleges and universities for panel discussions and free attendance at our Spring seminar. The Ozarks Chapter of AGA also plans to bring back college scholarships for the 2023-2024 program year.

### Membership

A goal of the Ozarks Chapter of AGA is to grow membership by 10% in the coming program year. Our reach will need to be engaging and accessible to everyone. By providing virtual and in-person meetings we will be able to reach those outside of Springfield and allow for marketing opportunities. The Ozarks Chapter of AGA will also offer 'bring a friend' for free to current members and reach out to new businesses or individuals to educate on AGA member benefits to help grow our membership.

### **Expected Challenges**

As with any organization, we are seeing a large decrease in membership, including CGFM™ designated individuals. The National AGA has worked to provide a CGFM™ study group for all Midwestern Chapters. The Ozarks Chapter of AGA is dedicated to providing various resources as members study for the CGFM™, including scholarships for those who pass and receive the CGFM™ designation. We also intend to establish a rewards system for members, which will help show our appreciation and support of active members.
