Our Finances Revenues and Expenses

What are the costs for servicing our members and how are those costs paid?

The VA Peninsula Chapter does not collect chapter dues from its members, so all revenue to provide for services it provides must be raised. We generally do this through holding two professional development training (PDTs) annually, one in the fall and one in the spring. In 2022, we held our 27th annual fall conference, the AGA Commonwealth PDT, for the second year virtually, together with the Richmond, Southwest VA, and Shenandoah Valley chapters of AGA. In the spring, we unfortunately did not hold our normal joint conference with ASMC after our longtime partner, the Hampton Roads Chapter of ASMC, decided to pursue a different type of spring conference without us.

Thanks to the success of prior years' PDTs and the chapter's conservative spending, we were fortunate to have a significant enough account balance to make a significant investment into the future of our profession. Our chapter executive committee voted to provide \$25,000 to the Hampton Roads Community Foundation to endow a scholarship that will provide an annual scholarship to a graduate or undergraduate student from our area in perpetuity.

Continue to Adopt, Pivot and Grow in a Changing Environment

Membership is such a critical part of a health professional association and like many others, our chapter is challenged to bring retain and recruit members. We are continually looking for volunteers to help us plan and offer member services.

We face significant audio-visual fees in trying to emerge from the pandemic and offer our 27th Annual Commonwealth PDT as a hybrid event. We continue to look for a partner for our spring PDT. 5

We continue to offer our members free access to our monthly meetings, which are worth 1 CPE each. Our CGFM study group meets consistently, has grown and we expect several new CGFMs this year.

2022-2023 Chapter Goals:

Our goals for the coming year include:

- Membership growth:
- Overall Membership Satisfaction: 85% satisfaction (meets or exceeds expectations)
- Training Events: Offer 25 hours of CPE with networking opportunities before and after each meeting.
- Educational Meeting Attendance: 100 average attendees for fall and spring PDTs. 20 average attendees for meetings.
- Educational Meeting Satisfaction: 75% satisfaction (meets quality expectations) as measured by polls at monthly meetings
- CGFM Candidate Support: We are continuing to provide a study group and offer an reimbursement incentive for the first chapter member certified this year.
- CGFM Support: 80% CGFM retention.
